2. The requisite information in respect of Oman is given below:-


The Royal Oman Police regularly conducts special operation in coordination with the Ministry of Manpower in campaign to arrest violators of labour law in which illegal residents and visa violators are arrested and detained from time to time. The details of such detained illegal immigrants are not provided by the Omani authorities to the Mission.

However, the detained illegal immigrants are kept in custody by the Omani authorities for a short period and deported. Jail authorities bring them to the notice of the Embassy for consular assistance.

If you are aggrieved with the reply, you may prefer an appeal with Shri A.P.S Chauhan, First Secretary (HOC/CW), Embassy of India, Muscat, Appellate Authority within 30 days of receipt of this reply.

It is hereby submitting that one Indian Citizen named Nissar Pothath, aged about 28 yrs, S/o. Mohammed Kutty Pothath, Koyikkalparambath House, Velliparamb, P. O. Kuttykattoor, Kozhikkode Taluk, Kozhikkode District, Kerala State had passed away on 10.11.2011, when he was working as an electrician at Muskat in Oman State. Body of the said person had been brought to India on 12.11.2011 through the Indian Embassy on a declared holiday in Oman.

Now it is hereby requesting to furnish the following details with respect to the death of above said Indian Citizen named Nissar Pothath died in Oman under the head of questions and answers.

1. Kindly furnish details keeping under the custody, in respect of the treatment of demised person on the day of death.
2. Kindly furnish the details of the hospital and name of doctors, who treated the demised person at the time of death.
3. Kindly furnish the name and address of the sponsor and employer of the demised person.
4. Kindly furnish copy of the report of death of the above said person collected by the Indian Embassy at Muskat.
5. Kindly furnish the copy of postmortem certificate holding by the Indian Embassy at Muskat with respect to the death of the above said person.
6. Details of the persons(Indian Citizens), who had taken active roll in transferring the dead body of the above said person to India.
7. Whether the Indian Embassy, Muskat had enquired about the cause of the death of the above person? if yes, kindly furnish copy of the report.
8. Kindly furnish the copies of documents holding by the Indian Embassy, Muskat with respect to the transportation of the dead body to India.
