Notice Inviting Tender

Sealed quotations are invited under two bid systems from contractors with a minimum experience of three years for the Air Conditioning fitting job to be undertaken at Embassy of India, Muscat. The details of the job to be undertaken are as follows:

Scope of work for manufacture, supply and installation of condenser coils:

The work will also include the following:

- 1. Mobilize to site.
- 2. Visually inspect the unit and review work procedure.
- 3. Isolate the unit supply on control and power circuits.
- 4. Recover gas.
- 5. Dismantle old condenser coils from unit.
- 6. Install new condenser coils in to place and braze inlet/outlet connections.
- 7. Pressure test and flush the system.
- 8. Replacing compressor oil and drier filter.
- 9. Vacuuming, Gas charging using recovered gas.

NOTE: All the above stated work should conform to Muscat Municipality Norms.

- 2. The tender documents may be obtained from the office of the undersigned at Embassy of India, Muscat, Diplomatic Quarters District, Al-Khuwair from 1100 Hrs to 1600 Hrs by payment of OMR 3.000 only (by cash/demand draft) on any working day up to 15.02.2016.
- 3. The above-mentioned work (air conditioning fitting job) may be seen at the site from 1100 Hrs to 1600 Hrs on any working day upto 15.02.2016.
- 4. Successful bidder will be asked to deposit, within one week, an amount of R.O. 1200/- as performance guarantee and will be liable to carry out the above mentioned jobs at the bid price within a period of one month from the date of receiving the award of contract. Each job done will carry a warranty of one year. Guarantee amount shall be returned after successful completion of guarantee period of the last work done. No interest shall be paid on the guarantee amount. Service provider will use only 'A' grade material.
- 5. In case the bidder refuses to carry out the above mentioned job at the bid price or delays the job or does not carry out the job satisfactorily the performance guarantee shall be forfeited.
- 6. The bid is to be submitted in two separate sealed covers one for Technical Bid and the other for Financial Bid. Both covers may be enclosed in one sealed main cover which should indicate "Quotations for manufacture, supply and installation of AC's condenser coils". The validity of the bids will be 90 days. Embassy reserves the right to reject any or all bids without assigning any reasons. The successful bidder will have to sign an Agreement attached to the tender document.
- 7. The quotations must reach the office of the undersigned at Embassy of India, Muscat by 1700 Hrs on 15.02.2016. The Technical Bid will be opened in Room No. 112, Embassy of India, Muscat at 1100 Hrs on 16.02.2016. Only technically qualified bidders will be informed of the date and time of opening of Financial Bid in due course.
